## Sub: RBI EDPMS - Exemption from provisions of Caution listing extended till 31/12/2018

As members are aware that caution listing on account of RBI - EDPMS (Export Data Processing and Monitoring System) has been a cause of concern as it impacts export shipments, document submission to buyers and also resultant business.

RBI vide its circular No.74. Dated May 26, 2016 (<a href="https://www.rbi.org.in/Scripts/NotificationUser.aspx?Id=10423&Mode=0">https://www.rbi.org.in/Scripts/NotificationUser.aspx?Id=10423&Mode=0</a>) has given instruction to AD Banks on Caution/ De-caution Listing of Exporters. The RBI has since then extended time to AD Banks and exporters to get all the Shipping Bill pendency cleared in the EDPMS till 30thSeptember 2018. A further extension to the Caution Listing process has now been given by RBI till December 31, 2018.

Since the RBI is still receiving lot many representations/complaints from various export bodies/exporters stating that their shipping bills are shown outstanding in EDPMS despite submission of requisite documents by them. RBI has instructed to the AD banks to step up efforts to mark off such entries quickly without any further loss of time. To enable the AD banks to complete the process, a 3 month additional window is being provided. Accordingly, the provisions of auto-caution listing will not be enforced till December 31, 2018.

In the view of the above, we urge all the affected members to kindly pursue their AD Banks to update all the old entries in the EDPMS before 31st December 2018 to avoid getting Caution Listed.
