## Sub: Regarding training about MEIS application for OFAC-sanctioned countries

We wish to inform that O/o Addl DGFT Mumbai is organizing Training on MEIS application for OFAC-sanctioned countries on 22<sup>nd</sup> July 2019. As program is aimed at explaining the procedure to apply for MEIS incentives without the bank's e-BRC specially for export order executed to OFAC sanctioned countries.

In this regard DGFT has already issued Public Notice No.8 dated 14.05.19 and Trade Notice No. 15 dated 16.05.19 explaining a new procedure to apply for MEIS incentives without e-BRC. This training program will bring clarity with regard to online application procedure and also to resolve the queries from the stake holders.
