<u>Subject : Examination of complete import profile to identify opportunities for Indian Exporters in</u> <u>Korea RP</u>

We wish to inform that FT (NEA) Division, Department of Commerce, Govt. of India has done analysis of the existing trend for trade with Korea RP and the potential of trade between India and Korea RP in future by making a scrutiny of import profile of the country vis-à-vis export potential of Indian products to world. A list of the products which India may have the potential for export to Korea (culled out as the data of India;s exports to world), but are not being exported to Korea is attached (refer Annexure 1)

In addition to this, at our end we have undertaken further analysis and enlisted Panel wise products (please refer annexure 2 attached) in which India's share of plastic products in Korean market and Indian potential are given.

Members are requested to refer both the attachment and provide urgent inputs on (i) Barriers faced by the exporters (ii) unfairness in market access (iii) remedial measures for enhancing exports of their products to Korea.
