## SUB: SUGGESTIONS FOR PRE - BUDGET PROPOSALS FOR THE YEAR 2020 - 21

We are pleased to inform our members that Budget proposals for Pre-Budget Exercise of the Union Government for the year 2020-21 is being invited by the Department of Commerce, Government of India.

Suggestion may be forwarded which are considered to be export-import realted and in the light of the following :-

- Budget proposal should be complete in all respects, properly categorized and HS codes for each commodity must be provided.
- Justification given in favour of the proposals shall be restricted to 300 words and Annexures should be used if necessary.
- Issues discussed year after year but never agreed to, may not be raised again.
- There is a serious fiscal crisis. Therefore, proposals of small reduction/exemption in custom/excise duties, service tax etc should be avoided unless they are absolutely necessary if such reduction/exemption are necessary, then ample justification should be given.
- Where temporary relief has been given to some sector for particular period (i.e upto 31.03.2020), then it should be re-examned and views may be submitted on these as well.

Members are requested to send their Concrete and relevant Pre–Budget proposals/suggestions with justifications as per prescribedroforma I & II ((I & II (copy losed) latest by 10<sup>th</sup> Sept' 2019 to the undersigned at bharti@plexconcil.org
