<u>Subject : Protocol of the 7th India-Russia Working group on Modernization and Industrial Cooperation under the</u> <u>India-Russia intergovernmental commission on Trade, Economic and Scientific, Technological and Cultural</u> <u>cooperation held on 29th August,2019 in New Delhi- ATR reg.</u> <u>Ref. No. : 46016/27/2011-TECH-CPC</u>

We wish to inform you that we are in receipt of a copy of protocol signed of 7" session of working group on modernization and industrial cooperation. They have requested for Action Taken Report (ATR)/comments on the following paragraph(s) for action by industry which are relevant to them. The points on which Action is to be taken are reproduced as under:

a) "Indian Side noted the position of the Russian Side regarding the issue of implementation of restrictive measures with the use of the mechanism of price undertakings in respect of supplies of chemical products of Russian origin to Indian market."

b) "In the framework of the work related to discussions of imposing of free trade regime between the Republic of India and the EAEU (Eurasian Economic Union) member-states (Armenia, Belarus, Kazakhstan, Kyrgyzstan and Russia.), the Sides agreed within their competence to consider the possibility of zeroing of the import customs duties on certain types of chemical products. The names of chemical/petrochemical proposed for supply to Indian Market to be specified by the Russian side and the duties may be brought to zero on the specified Chemical and Petrochemical after evaluation'.

c) "The Russian Side informed about the readiness of M/s Plastopolymer to organize supplies of the materials for Indian production of two-component caps and crown corks. The Indian Side agreed to provide assistance to M/s Plastoplymer in establishment of the direct business contracts with Indian companies interested in the development of cooperation".

d) "The Russian Side informed about the readiness of M/s HaloPolymer to organize supplies of polytetrafluorethylene and sulphur hexafluoride of its own production to interested enterprises of the Republic of India. The Indian Side agreed to provide assistance to M/s HaloPolymer in establishment of business contracts with potential partners'.

e) "The Russian Side informed about the readiness of M/s Shebekinskaya Industrialnaya Khimiya to organize supplies of chemical materials to the Indian market for leather and fur industries, as well as supplies of regents and drilling fluids for oil and gas industries of its own production'.

f) "The Russian Side informed about the readiness of M/s Gazprom Khimvolokno to organize the supplies of technical and cord fabrics of its own production to interested enterprises of the Republic of India. The Indian Side agreed to provide assistance to M/s Gazprom Khimvoloknno in establishment of business contracts with potential partners'.

g) "The Russian side informed about the readiness of M/s Roshimzaschita Corporation to organize the Suppliers of Safety systems to interested enterprises of the Republic of India. The Indian side will examine the issue".
