<u>Subject : Regarding Govt. is considering licensing regime for unknown imports (as per media report)</u>

<u>Ref. : Silicones in primary forms (3910.00.90) – Others & Organo Inorganics Compound (2931.90.90) – Other</u>

We wish to inform you that as per the media report, Indian Govt. may introduce license for certain imports of products and also putting them in restricted category wherein the additional custom duty has also been proposed. Few of such products are as follows:-

Chapter - Silicones in primary forms (HS code 3910.00)

- 1. Silicones Resins (HS code 3910.00.10)
- 2. Silicones Oil / Fluid viz : Dimethyl Oil/Fluids, Amino Methyl Oil/Fluids etc. 3910.00.20
- 3. Others including Raw materials -rest are (HS code 3910.00.90)

One exporter has already approached the Govt., not to impose additional duty on the above said products and requested that these products may be excluded from restricted list.

Members are requested to give their input whether the said product should be included in restricted list, if so the reason thereof.
