## 1. Growing Demand for Plastics & Rubber

In 2020, the production of plastic products will reach 12.5 million tons and export turnover will be USD4.3 billion, followed by a growth rate of 15% each year later. # 3. Local Plastics Industry Rising



These plastics products have gradually reached the point to where it can control the market of several countries.

## 4. High Value FDI Attractor

In the 1st quarter of 2019, Vietnam has received around \$16.74 billion in FDI. Foreign investors are investing in 19 different sectors of Vietnam economy. To enter this high value market, the 19th Vietnam International Plastics & Rubber Industry Exhibition is your finest choice.

# 5. Substantial opportunities toward EU market

Vietnamese Government and the Ministry of Industry attach great importance to the plastics industry by establishing 5-year development plan to stimulate growth in the production of high-tech plastic parts and developing the recycling industry.

#### **Market Overview:**

Vietnam is an open economy in ASEAN Markets and is one of the most preferred destination for trade by developed countries. The country has been steadily developing its economy by signing important trade deals and agreements like **APEC membership** in 1988, **WTO accession** in 2007, **Participation in ASEAN Economic Community** and the latest & most important **EU – Vietnam Free Trade Agreement (EVFTA)** in 2019 which by itself proves its commitment for making Vietnam a hub for Global Trade. With trading flow of **US\$471 billion** and GDP of **7.08%** in 2018 Vietnam witnessed a high economic growth in a decade. The country's foreign direct investment (FDI) sector accounts for approximately 22 per cent of its economy with an investment of USD\$ 38 bn and has seen an increase in investment of 7.2% on Y-o-Y which by itself shows Vietnam as a preferred destination by the nations for their industry & trade. The country strong economic growth, reforms and demographic advantage makes it an ideal destination for trade.

Vietnam's exports have doubled as competitive minimum wage and low costs of utilities boosted foreign direct investment in the manufacturing sector. Vietnam main semi - finished goods exports are: **telephones, mobile phones** and **parts thereof** (21%), **textiles** (12%), **computers and electrical products** (12 percent); **shoes & footwear** (7 percent) and **machinery, instruments and accessories** (6 percent). Its main export partners are: **The United States** (19%), **China** (16%), **Japan** (8%), **South Korea** (7%), **Hong Kong** (4%) and **Netherlands** (3%). The statistics clearly indicates that the Vietnam market is preferred to be a destination for manufacturing of varied goods and opens the destination for exports to the high potential markets including developed countries.

For India, Vietnam is an important destination for trade development. The Country provides a strategic opportunity to also explore business opportunities and Cambodia & Laos. Its economy is dominated by major industries like Agriculture, Automobiles, Construction & Building Materials, Food, Logistics & Real Estate.

Vietnam plastics industry is still a new sector compared to others such as mechanical, chemical or textile industry; however, it has experienced tremendous growth in both revenue and profitability, with annual estimated growth rate of 16 to 18 per cent. There are currently more than 2,200 plastics companies operating in Vietnam with the number of domestic companies accounting for 85 per cent. This has resulted from an ever-increasing consumption of plastic products which are widely used in several industries and economic sectors such as: power, electronics, telecommunication, communication and transportation, aquatic products, agriculture, etc. Forecasting to 2020, domestic plastic producers will need about 5 million tons of

input raw materials for production flows and activities. The total plastics imported in Vietnam is  $\sim$  USD \$ 15 bn whereas India's export to Vietnam is  $\sim$ USD \$ 200 Mn.
