NOTE

- 1) In order to stand for the election a candidate or the entity represented by him / her must have to his / her / its credit export turnover (FOB value of physical exports) of not less than Rs. 2 Crores in the immediate preceding financial year or average export turnover of Rs. 2 Crores per annum for the preceding three financial years.
- 2) In order to qualify for reserved seat for MSME category, the candidate or the entity represented by him must have to her/ his/ its credit, the export turnover (FOB value of physical exports) in the immediate preceding financial year of a minimum of Rs. 50 lakhs per annum, or average export turnover of Rs. 50 lakhs per annum for the preceding three financial years.
- 3) Only the authorized representative, whose name is mentioned as such in the membership application, while applying for membership with the Council shall be eligible to contest, propose or second at the Election.
- 4) However, in the absence / non-availability / unwillingness of such authorized representative, any person who is duly authorized by the existing partners / directors / managing committee member / trustee etc., as the case may be, shall be eligible to contest for the Election. Provided that the name of such authorized person as partner / director / managing committee member / trustee etc. is registered with Director General of Foreign Trade (DGFT).
- 5) Any Ordinary Member de-registered or black-listed under the Foreign Trade Policy with regard to exports / imports will not be eligible to file nominations for election to the Committee of Administration. Therefore, on the original Nomination Form itself the Member organization will also have to submit a declaration in writing signed by the Chairman / Managing Director / Director / Partner/ Proprietor as the case may be that it is not debarred/black-listed under the aforesaid Policy.
- 6) The 3 members of the COA to be filled up shall be elected by the members for their respective regions. The region wise vacancy is as under:

• Western Region – 1 Post – General Category
