### **IMPORTANT NOTICE**

Kindly refer our communication Ref No. : Plexh/Election/146 dated 13<sup>th</sup> October, 2020 regarding invitation of nomination in the election process for filling up the vacant posts in the Committee of Administration 2020-21.

In the said communication we had mentioned the link for verifying the list of Ordinary Members who would be eligible to participate and vote in the election process, but unfortunately due to genuine human error we have inadvertently sent the link of Ordinary Member list of previous year i.e. 30<sup>th</sup> June, 2019 instead of 30<sup>th</sup> September 2020. We sincerely regret the inconvenience caused to our valued members. Please note that the correct link for the list of Ordinary Members as on 30<sup>th</sup> September, 2020 is as under.

The nominations received by 27<sup>th</sup> October, 2020 (Tuesday) would be scrutinized by the returning officer nominated by the Government of India on 28<sup>th</sup> October, 2020 (Wednesday) subject to the availability of returning officer.

Nomination can be withdrawn by the candidate by giving a letter signed by him/her/them latest by 4<sup>th</sup> November, 2020. Withdrawal of nominations by electronic means such as emails will be considered or accepted by the Election Committee. Such a withdrawal shall be final and no subsequent request, for rescinding such withdrawal shall be entertained by the Election Committee.

The final list of candidates for election would be published on 6<sup>th</sup> November, 2020. The same would be uploaded on Council's website and on the notice board of the Council at its Head Office.

If there is more than one candidate for each post then election would be conducted. The election would be conducted from 10th - 12th November 2020 by e-voting. A separate communication on e-voting process would be sent to the members separately if the election is held for any post.

The final list of the elected candidates would be declared on 13th November 2020 which would be uploaded on Council's website and on the notice board of the Council at its Head Office.

We request you to refer our earlier communication Ref No. : Plexh/Election/146 dated 13<sup>th</sup> October, 2020 for the details of the vacancies and the terms & conditions and modalities of the election process.

The decision of the Election Committee in this regard would be final and binding on the members. We request all the members to note the above and actively participate in the election. For any further clarification kindly contact the undersigned at ed@plexconcil.org.
