<u>Subject</u>: Regarding Introduction of Electronic filing of RCMC through the Common Digital Platform by DGFT w.e.f. 06.12.2021

Ref.: DGFT Trade Notice No. 27/2021-2022 dt. 30.11.2021

We would like to draw your attention to the Trade Notice No. 27/ 2021-2022 dt. 30.11.2021 by DGFT (https://content.dgft.gov.in/Website/dgftprod/a0ecf3e1-efe0-4e56-adda-429cd96a152a/TN.pdf) regrading Electronic filing of Registration Cum Membership Certificate (RCMC) / Registration Certificate (RC) through the common digital platform w.e.f. 06.12.2021.

Please note that Submission of Fresh / Amendment / Renewal of RCMC on this new online platform shall not be mandatory for the exporters during the transition period up to 28 Feb 2022 or until further orders. Therefore, Plexconcil Members may continue to submit their RCMC application on the existing Plexconcil Platform during the transition period.

Members may please take note of the following points with regard to the process being notified herewith:

- a. Digital Signature Certificate (DSC)/ Aadhar would be required for the purpose of electronic submission of applications. The digital signature would be the same as used in other DGFT applications;
- b. No separate registration is required for availing the RCMC/ RC service from the DGFT Portal. Already registered exporters/importers can avail the service using the same login credentials.

Alternatively, for guidance on registration and application for submission of RCMC on common digital platform, exporters may refer the Help Manual and FAQs accessible on DGFT Portal under the navigation - Learn >> Application Help & FAQs.
