You are requested to please note that MSME's of Manufacturing / Service sector having valid Udyam Registration are eligible for availing reimbursement benefits of the expenses incurred for any approved domestic exhibition participation upto the cap of Rs.1.5 lakhs or actual whichever is lower which includes Space Rent Charges and Contingency expenditure (travel, publicity & freight) as per the guidelines of "Procurement and Marketing Support" scheme of Ministry of MSME and subject to approval of Ministry of MSME.

For availing the Domestic Exhibition Reimbursement benefits <u>Udyam Registration and MSME DataBank</u> <u>Registration is mandatory!!!!</u>

Eligible MSME exhibitors participating in approved domestic exhibitions are urged to register themselves for Udyam Registration and MSME Data Bank Registration through www.msmedatabank.in to avail the reimbursement benefits.

"Only first 60 Micro and Small category units of MSMEs (Manufacturing and Service Sector) who register for grant on MSME portal " are eligible for the availing the exhibition reimbursement grants subject to Ministry of MSME's approval!
